Re: Crisis Intervention Counseling through FNHB



Dear Chief & Council

We have heard from many of our Member Nation that mental services are a priority for our people. We want to ensure that all of our community members have the information they need in order to access crisis mental health services.

Here are the steps for accessing the services:

- If your community is covered by a contribution agreement your Band office will have the information about accessing services if you live on reserve in your Nation.
- If you are not covered by a contribution agreement, contact one of the registered mental health providers on the attached list.
- Make an appointment with the mental health provider for an initial assessment.
- The mental health provider requests prior approval from the ITHA Health Benefits for your initial assessment.
- At your initial assessment, the mental health provider will determine if you are at risk or in crisis.
- If you are at risk or in crisis then the mental health provider develops a treatment plan for you and forwards the treatment plan to ITHA for approval and ITHA informs the mental health provider how many sessions are approved as part of your treatment plan.
- You and your mental health provider complete the treatment plan.
- You sign the invoice form created by the mental health provider, who then forwards the form to the ITHA for payment.
